Terms and Conditions

By participating in the “**CDL E-Generation Challenge**” (the “Competition”) organised by City Developments Limited (CDL) (the “Organiser”), you unconditionally agree to be legally bound by these Terms and Conditions.

OBJECTIVE

- 1 CDL E-Generation Challenge is intended to raise eco-consciousness amongst the youth, utilising an eco-tainment platform as participants learn more about environment-related issues while engaged in a fun rally around Singapore. This Competition reinforces CDL’s long-standing commitment to the development of the youth and environmental outreach in Singapore.

ELIGIBILITY

- 2 The competition is open to all youths residing in Singapore from 17 to 25 years of age, born between 1 January 1987 and 31 December 1996. Participants under 21 years of age must seek parental consent.

COMPETITION BRIEF

- 3 Each team will comprise **6 members**.
- 4 This is a fun rally on foot and public transport only. Teams will be disqualified if found to be commuting by any other means. In the interest of safety, teams are strictly not allowed to run inside the MRT Stations. Penalty points will be given to teams found violating this ruling. All costs incurred for transportation will be borne by the respective teams.
- 5 The onus is on the teams to be prepared for the event (i.e. mobile phones, batteries, EZ link cards with sufficient amount for public transportation, water, etc). All costs incurred in relation to the competition are to be borne by participants, i.e. the Organiser will not reimburse cost incurred by participants.
- 6 Participants are to ensure that they are medically fit and not suffering from any disability or condition that could pose a potential risk to either them or others.

START

- 7 The Start of the event will be at City Square Mall (See *Annex 1* for map). Participants will be required to report to the Start at 7.00am. The Flag-off will commence at 8.00am and Teams will be flagged off in intervals.
- 8 Teams with less than 5 members will be disqualified.
- 9 The Organiser reserves the right to disqualify teams that report late to the competition venue.
- 10 All participants must wear the competition t-shirt and suitable running shoes.

DURATION OF EVENT AND SCORING

- 11 Each team will have their Start Times and End Times recorded. Any amendment to this method of determining End Time will be advised at the Briefing Session.
- 12 Participants will be given five (5) hours from their official time of departure from the Start to complete the event. Participants must return to the End within the given five (5) hours. Participants will be penalised for every minute that they are late in returning to the End, up to a maximum of fifteen (15) minutes. Participants returning to the End in excess of the extra fifteen (15) minutes will be disqualified.
- 13 Participants must be prepared to take part in rigorous activities that require motor skills, stamina and endurance. These activities may include water sports as well as the ability to manoeuvre a vehicle of less than four wheels.

- 14 Navigation will be by means of maps and photographs. With the help of cryptic clues and riddles, participants will be required to look for answers to questions set en-route. Participants will also be required to complete games, quizzes and brain teasers (if any). Points will be given to correct answers and games will also be scored. The Team with the most points wins.
- 15 Participants are requested to always follow the Event Marshalls' instructions and will always be attended to on a "first-come, first-served" basis.
- 16 Do not waste time at Game Stops or spend too much time looking for answers. If you cannot find the answer, proceed to the next question – try to answer as many questions as possible.

FINISH

- 17 The Finish will be at City Square Mall. Lunch will be served at the end and results and prize presentation will be at 3.00pm (time subject to changes). There will be entertainment for the participants while waiting for the results to be computed.

TEAM PRIZES

- 18 The team prizes are as follows:

- 1st Prize: \$2,000 cash**
2nd Prize: \$1,500 cash
3rd Prize: \$1,000 cash

Team members from all finisher-teams will be eligible for a Lucky Draw which will be conducted during the prize presentation. Each team member will also receive a goodie bag.

INSTITUTION CHALLENGE

- 19 In addition to the team prize, participants representing their schools / institutions will also contribute towards their school / institution's chance to win the Institution Challenge, for which a \$1,000 cash donation will be made to their school / institution.
- 20 The points scored by the teams representing their schools / institutions will count towards their school / institution's total. The aggregate points scored will then be averaged amongst the number of representative teams.
- 21 The school / institution whose teams have the highest average score will be declared the winner of the Institution Challenge.

DISCLAIMER

- 22 The Organiser reserves the right to refuse acceptance of any registration and to disqualify Teams that report late to the Start. The Organiser reserves the right to disqualify any team that fails to comply with the rules of this Competition.
- 23 The Organiser shall decide all matters relating to the conduct of this Competition and the interpretation of the rules as well as all matters not mentioned in these rules. The decision of the Organiser will be final. No appeals or correspondence on the subject will be entertained.
- 24 The Organiser reserves the right to draw reserve winners to substitute any winning team subsequently found to be disqualified.

- 25 The Organiser reserves the right to cancel, postpone or change the venue, date and/or time of the Competition at its discretion due to inclement weather, facility problem or any other situation deemed as appropriate without prior notice.
- 26 The Organiser reserves the right to remove any participant deemed physically incapable of continuing with the Competition to prevent him/her from causing greater harm and injury to himself/herself.
- 27 Whilst every reasonable precaution will be taken by the Organiser to ensure the participants' safety, participants partake in this Competition at their own risks and the Organisers and their appointed officials shall not be liable for any loss and/or damage, whether personal or otherwise, and howsoever arising.
- 28 The Organiser, its servants and/or agents shall not be responsible for any consequences including but not limited to loss of life, injury to person and/or damage to property arising from or in connection with the Competition and/or redemption or use of the prize.
- 29 Participants agree to waive all claims of action against the Organiser arising out of their voluntary participation in the event and hereby release, hold harmless, and discharge the Organiser from all liability in connection therewith. It is recommended that participants obtain appropriate insurance coverage to cover both their own personal wellbeing as well as liabilities to third parties.
- 30 Participants consent to the public disclosure of his/her name and photographs, as the case may be, for publicity purposes or otherwise participate in the publicity activities of the Organiser in relation to the Competition and to the use of any data provided by such winner for any future publicity effort by the Organiser, without any payment or compensation thereof.
- 31 Winners shall bear all costs associated with the participation of the Competition, the claiming and collection of the prizes from the Organiser.
